As we end the tenure of the Board of 2023-25, we can look back with satisfaction on our various achievements. First and foremost our spending on our various charitable activities exceeded Rs 8.5 crores in the recently concluded fiscal with nearly Rs. 2 crs being for upgrading our medical infrastructure. This should help us impart quality health care in the coming years!

However while quanta of finance has its significance, more important is its effective use. And on this front too, MID was not found wanting. We created a record of sorts by having as many as 556 community outreach programmes. Also, these were not one-dimensional but on multiple fronts. They included:

- Doctor at Door Step** – Mega Camps in Delhi NCR – 140
- Doctor at Door Step** – Mega Camps outside Delhi NCR – 152
- Jhanki Nanhi Aankhon Mein** – School eye and basic health camps – 96
- Project Janitri** – Health counselling of pregnant women & lactating mothers - 57
- MID Anjuman** – Weekly outreach clinics in slums of Delhi NCR - 111

Add to this the nearly 2000 cataract correction surgeries that we have conducted or facilitated and the approximately one lakh patients that have been treated in our centres, we have all reasons to feel justified as a holistic health care provider for the underprivileged.

Significantly, MID added a feather to its fulsome cap by taking on and completing a water recharge project in the rain parched district of Alwar at Kathuwas. The first rains have already proved beneficial with water level going up by scores of feet at a few locations!

In backdrop of the above, I feel very privileged and fortunate for once again being a part of the 2025-27 team, which will be carrying forward the various initiatives. Firstly, a fervent prayer to Almighty to continue to shower His grace on our organization so that we continue to do His work.

However, in return for this grace, we also need to step up our interventions. So a humble appeal to all members to please actively participate in our various interventions and more importantly, mingle with our beneficiaries. It needs no emphasis that compassion has to be the cornerstone of an organization inspired by the universal message of Love All Serve All espoused by Lord Mahavir. The term for 2023 -25 has ended on 31st -March -2025 and once again Delhi centre has provided it's best by serving the poor and the needy to achieve the mission of "LOVE ALL -SERVE ALL"

The performance for these two years is as under:

Donation for the year **2023-2025** is **Rs. 12.77 crore** including foreign donations of **Rs. 1.47 Crore**. Sincerely thankful to our sponsors **CONCOR, PETRONET, IOCL, GAIL, IGL, IRCTC, RAJDHANI BESAN GROUP, SAFEXPRESS PVT LTD, MANGALAM, INOXGFL, SSS FOUNDATION, Vibes Healthcare Ltd, Tamil Federation, Sh. Raj & Vandana Jain (USA), MARC Group**, to name a few and our esteem members.

During the tenure 2023-25 we received a donation of **Rs. 221.45** as CAPEX donation. **Two Eeco Vans** and **One Trax Cruiser** were added to the infrastructure of MID under CSR initiative of **PETRONET LNG LTD, CONCOR** and **IGL. 14 sets of Medical equipment's from PETRONET and IRCTC** for use in **CAMPS & HOSPITALS**, out of these 8 sets have been handed over to Mahavir international Centres on PAN India basis namely **Indore, Gwalior, Jaipur, Hyderabad, Sumerpur Sheoganj, Jodhpur, Shree Mahavirji and Golakot** with a motive to provide the medical facilities on regular basis and for use in CAMPS for better services.

Mahavir international Delhi has to 2 fully equipped Eye Check up Vans to provide the facilities of EYE check up in the Vans itself. Other than this **IOCL** has provided us **Rs. 68 lac** for upgradation of our pathological lab at **NABI KARIM** and eye care equipment for hospital. **NMDFC** has generously provided a new Dental Clinic facility at **Lala Aman Singh Jain Charitable Centre, Hauz Rani, Delhi**. This initiative will enhance our healthcare services by providing quality dental care to the underprivileged community.

An MOU was signed with **TAMIL FEDERATION of Reunion island** and **ANNAMALAI UNIVERSITY** for **approximately Rs. One Crore** grant by **Tamil Federation, Reunion Islands** for interventions in Tamil Nadu including around 70 lakhs in districts of Cuddalore and Myladiturai (to be implemented by Annamali University). This mainly comprises of support for Installation of Medical Equipments in the **Govt. Primary Health Centre (PHCs)** and Infrastructure facilities for the government schools. Additionally **MI Chennai Metro and GK Jain Charitable School** located at Royapuram, Chennai also stand to gain by way of medical equipment and computer lab respectively.

MID is able to pursue it's main objective of providing primary health care services through all three hospitals at **Nabi Karim, Hauzrani and Badarpur. 2,38,696 patients** were checked in the OPD and **3,302 patients** with cataract surgeries. **57 Weekly Anjuman Clinics** were organized in which **6,057 patients** were benefitted.

During the tenure of these two years 2023-2025 under the flagship programme '**Doctor at door step**' MID organized **694 CAMPS. 417 CAMPS** in **DELHI NCR & 277 Camps pan India** with the help of other center of Mahavir international. Under the flagship project of '**Doctor at door step**', **MID's target was to organize One Camp a day** and I feel happy and proud to share that this year 2024-2025 we achieved this target of 'One Camp a day' by organizing total **388 CAMPS in a year**. Delhi centre has organized **248 CAMPS (152 mega camps and 96 JNAM School camp)** & **140** were organized by our other centres of Mahavir International. The partnership with other centres has given us strength to take up the projects on PAN India level.

Organizing 248 camps in Delhi & NCR required a lot of planning, dedication, and commitment. I sincerely congratulate all my staff members for achieving the target & salute their dedication, commitment, loyalty to MID.

MID is actively running Project Janitri across its health centers to educate young girls on menstrual hygiene and support young mothers in breast feeding. This community outreach initiative aims to enhance maternal and child health, reducing pregnancy and childbirth complications. Workshops cover menstrual hygiene, sanitary napkin usage, prenatal care, nutrition, safe delivery, postpartum care, breast feeding, birth spacing, and the benefits of a small family. **In 2023-24, BI World facilitated 24 Janitri workshops, while in 2024-25, CONCOR has supported with 30 workshops, further strengthening our efforts in community health education.**

New project of **Swastha Saheli** for **medical guidance** in the field of **Breast feeding** and other related issues was also launched and more than **two lac women** were educated.

A Nursing assistants programme called **GDA**, was also started to empower the unemployed youth. Programme is certified by Apollo Hospital and **47** youth has been successfully achieved the certificates. Other than the regular hospital, MID also started One Project on sewing training under initiative **SWAVLAMBAN** project for **WOMEN EMPOWERMENT INITIATIVE** of MI Apex under the wings of Vira vision was at Rajdhani Charitable Eye and Medical centre Nabi Karim and 57 students successfully passed.

Other than medical facilities, MID has ventured in a new field in environmental betterment in partnership of CONCOR. A project of water project recharge had been successfully completed in **CONCOR terminal at KHATUWAS** Rajasthan. This will be able to increase the ground water level by channelling the rain water available. The cost of this project was 95 lacs.

## Who We are & What We Do

Mahavir International Delhi (MID) was established in 1979 and has been engaged in social service activities since its inception.

### OUR VISION

Work selflessly and tirelessly towards laying foundation of creating a healthy society with special focus on timely diagnosis of diseases to prevent their aggravation in order to improve overall health of disadvantaged sections of society while aiming for a cataract free Delhi and ultimately, the rest of India.



### OUR MISSION

To expand reach and spread of health care facilities by organizing one mobile health check-up Camp a day in rural, remote and Jhuggi clusters areas by empowering people, especially women by creating knowledge and awareness about need for better health and hygiene through sustained publicity and prevention of diseases. Manage and operate more free or affordable medical and diagnostic centers and set up our own eye bank.



### OUR MAJOR FOCUS

Mahavir International's primary focus is health care with special emphasis on Eye care. Its motto is 'Love All Serve All' and mission is to make 'Delhi Cataract Free' as the said ailment is the major cause of blindness in the country (66% as per AIIMS report of 2018). It also works towards the elimination of blindness by motivating people for "Eye Pledge" and for "Eye donation" of those who have passed away. We have 3 charitable hospitals in Delhi. Our focus is on quality health services for the underprivileged in the city – including daily wagers, street vendors, migrant labour and their families with care, concern and compassion. OPD services are provided at nominal registration fee, along with free medicines and diagnostic tests at highly subsidized rates.





## OUR OTHER SIGNIFICANT PROJECTS

### 1. DOCTOR AT DOORSTEP

*“If patients can’t reach the Doctor then Doctor must reach the Patients” - MID*

Under our flagship project ‘Doctor at Doorstep’, by the end of this financial year, we have organized more than 4,200 free check-up camps, resulting in over 17 lakh consultations. Out of these, 400 camps and more than 1,40,000 consultations were conducted in FY 2024–2025 alone. These health check-up facilities are offered either in remote locations with limited access to quality healthcare or at locations in and around the premises or operations of our sponsors. The services provided during these camps include consultations with general physicians, lady doctors, eye specialists, optometrists, along with ECG and blood tests as required, and the distribution of medicines and spectacles. Patients diagnosed with cataracts are further facilitated with free or subsidized corrective surgeries at MID centers or our affiliated hospitals. Acknowledging the impact of these camps in terms of taking health care to the Doorstep of the poor, various leading Business and Corporate Houses including Public Sector Enterprises and Bank have come forward to give us grant for conduct of the same. They include **ONGC, IOCL, HPCL, GAIL, IGL, PETRONET LNG LTD., EIL, CONCOR, RITES, ALIMCO, NBCFDC, NSFDC, SAFEXPRESS, RAJDHANI FLOUR MILLS, VIBES, MARC and others.**



### 2. JHAKHE NANHI AAKHO MEIN (झांके नन्ही आँखों में)

Mahavir International recognises the need for early vision corection in the underprivileged children in absence of which other than suffering from health issues, their education also suffers. In earlier years MID Participated in Chacha Nehru Sehat Yojana of Delhi Government. Mahavir International has re-launched the project in a slightly modified form under the tag **“JHAKE NANHI AANKHO MAIN”** in this project Mahavir International is organizing camps in schools run by MCD and other NGO’s to carry out prompt vision correction by provision of spectacles in a timely manner. During the **F Y 2024-25**, 91 such camps were organised in resulting in check up of more that **19,082 students** and distribution of nearly 2000 spectacles.



### 3. SWABHLAMBAN (स्वावलम्बन)

Under the new initiative “**SWABHLAMBAN**” MID in its effort to empower the unemployed women in and around its centers is carrying out the following interventions:-



#### a. Sewing Training

MID has affiliated with **Singer** to provide up to six months of training in apparel production for underprivileged women living around its center at Nabi Karim. A total **137 women** have been trained till date. Further to encourage their entrepreneurial instincts, they have participated in fashion show as also in exhibition and sale of their products.



#### b. General Duty Assistants

Another such initiative has been the training of under privileged women as “General Duty Assistants”. The first course was started on 25th April, 2022 and till date **143 students** have been trained and certified by Apollo Mediskills. Almost all the trained beneficiaries have also been provided internship opportunities, with some carrying on in job.



#### c. Swasthya Saheli (स्वास्थ्य सहेली)

MID had taken-up the project SWASTHYA SAHELI for women where a trained GDA's are providing counseling on menstruation and women health issue as menstruation and breast feeding at our centres. Since it is start in March, 2023, nearly **35,568** women have been benefited with these services. We are also generating ABHA Card of patients who visit our centers, which will entitle them to avail benefits under PM Jan Arogya Yojna (PM-JAY). Till date nearly **1000 ABHA** card have been generated.

# 1 KATHUWAS PROJECT

CSR project sanctioned by CONCOR valued **Rs. 95 Lacs** this initiative involves excavation of five ponds to capture the run off of rain water and injecting it through 200 ft deep bores drilled and inserted with perforated pipes.

If all goes well mother earth will be richer by nearly a crore litres of water every year.

# VIRA VISION

## & THEIR ACTIVITIES

"Vira Vision" as the name suggests, comprises of a group of women members of MID working with compassion for all underprivileged in general and for women in particular. We adopt and implement some of the national projects initiated by MI Apex besides running our own local projects. There were three board meetings held of Vira Vision. Some of notable activities are enlisted below...

**1. MOTHER & CHILD CARE** under which we undertake distribution of baby kits for new born and sanitary napkins for mothers at government hospitals besides counseling the latter on cleanliness/hygiene.

**2. SWABHLAMBHAN** project, to vocationally empower women. This programme includes Sewing Classess being conducted in coordination with Singer .These training programmes are being conducted at our centres and till date 137 women especially youth have benefitted from these initiatives.

**3. SWASTHYA SAHELI** is another novel project to counsel women who visit our three centres on menstrual hygiene and breast feeding. Further, the counselling is done by women trained as General Duty Assistants as part of our Swavalamban project. Since its inception in March 2023, around 28,252 for Menstrual Hygiene & 7,316 for Breast feeding women have benefitted from this initiative till March 2025.

**4. OTHER WELFARE ACTS** which are carried out round the year such as Khushiyon ka Bazaar involving sale of cloths and other consumables against a token price, support to institutions caring for Alzheimer patients, financial aid for patients with limited means etc.

**5. PROJECT JANETRI** is our latest initiative to spread awareness of pre and post natal issues to pregnant women and new mothers through special workshops being planned at our centres. This includes distribution of baby kits and nutrients to the attendees. Total No. of 4,026 Pregnant and Lacting Mothers got benefitted through this initiative.

Another redeeming feature of these interventions is that the Viras personally contribute to support these impactfull projects and also interact one on one with the beneficiaries making them feel loved.

Vira Vision hopes to carry on with the above initiatives as also new ones with the spirit of Love All Serve All' in the coming times.
